NOTE: Credentials MUST be stored in order to pull DU/DO findings.

If your selected credit vendor uses a different Account Number and Password when running Fannie Mae DU/DO, you must add your vendor twice, once with the standard Account Number and Password, and once with the Fannie Mae DU/DO Account Number and Password. Only check the FNM box if the Account Number and Password entered are specific for Fannie Mae DU/DO.
